Your application has been selected for review in a process called "Verification." The law says that we have the right to ask you for this information before awarding Federal aid. If there are any differences between the information you provided on your application and that on your financial documents, we will submit the correct information to the Central Processing Servicer on your behalf.

**You will need to:**

1. Collect and make **copies of your and your parent(s)' signed Federal income tax forms, including appropriate schedules, W-2 forms, etc.** If you did not keep a copy of your 2005 Federal tax return, you may request a free tax transcript by calling 1-800-829-1040, or by completing Form 4506 on the IRS website at [www.irs.gov](http://www.irs.gov). The transcript must be signed and dated.
2. Fill in all sections and **sign** this worksheet. Please do not leave any items blank. Section F on the last page must have at least one parent signature.
3. Return all completed forms to the Financial Aid Department via mail, in-person, or fax.

Processing of your aid will continue after the verification process has been completed. To avoid delays, please submit the requested information as soon as possible. Please allow 4-8 weeks for verification to be completed and your eligibility for aid to be determined.

*We are required to review the requested information under the financial aid program rules (CFR Title 34, Part 668).*
